ORDER:

On 20.09.2021, the Hon'ble Chief Minister has made the following announcement:-

“அரசுப் பள்ளிகளில் படித்து 7.5 சதவீத இட ஒதுக்கீடு மூலம் தொழிற் கல்லூரிகளில் சேரும் மாணவர்களுடைய கல்விக் கட்டணம், விடுதிக் கட்டணம், கலந்தாய்வுக் கட்டணம் உள்ளிட்ட அனைத்தையும் அரசே ஏற்கும்.”

2. Accordingly, the Registrar, Tamil Nadu Agricultural University has sent a proposal to Government for sanction of tuition fee, hostel fee and all other fees including counseling fee for the students getting admission into Agricultural Professional courses through 7.5% seats on preferential basis for Government school students.

3. The Government, after careful examination of the proposal of the Registrar, Tamil Nadu Agricultural University hereby issues the following orders:-

- (i) the tuition fee, hostel fee and all other fees including counseling fee for the students getting admission into Agricultural Professional courses through 7.5% seats on preferential basis for Government school students shall be sanctioned as follows:-

(a) Course fee:-

For student studying under Constituent – Science, Constituent - Technology and Affiliated Colleges of Tamil Nadu Agricultural University, the course fee shall be paid to the respective institutions as Rs.50,225/-, Rs.60,000/- and Rs.50,225/- respectively;

(b) Hostel fee:-

Maximum of Rs.40,000/- (or) the actual hostel fee collected by the institutions, whichever is less shall be given as hostel fee;

- (ii) The Managing Director, Tamil Nadu Medical Services Corporation is permitted to incur an expenditure of **Rs.2,38,14,900/-** (Rupees Two Crore Thirty Eight Lakh Fourteen Thousand and Nine Hundred only) [Rs.1,33,34,900/- (Rupees One Crore Thirty Three Lakh Thirty Four Thousand and Nine Hundred only) towards Academic fee and Rs.1,04,80,000/- (Rupees One Crore Four Lakh Eighty Thousand only) towards Hostel fee] for the students getting admission into Agricultural Professional courses through 7.5% seats on preferential basis for Government school students as detailed below for the academic year 2021-2022:-

- (iii) The amount indicated in para 3(ii) above shall be disbursed to the respective institutions by the Tamil Nadu Medical Services Corporation based on the recommendations and specific orders of the Registrar, Tamil Nadu Agricultural University.
- (iv) The Tamil Nadu Medical Services Corporation Limited should initially remit 100% Course Fee and one quarter hostel fee in advance and subsequently pay the Hostel Fee one quarter in advance.
- (v) The fee concession to be reimbursed to Tamil Nadu Medical Services Corporation Limited for 7.5% Special Internal Reservation for Government School Students shall be adjusted at the time of sanction of Grants to the Tamil Nadu Agricultural University.
- (vi) The Registrar, Tamil Nadu Agricultural University is directed to issue the following instructions to all the Agricultural institutions:-
- (aa) The Agricultural institutions should not collect any fee from the students admitted into Agricultural Professional courses through 7.5% seats on preferential basis for Government school students.
- (bb) The Refundable Caution Deposit for Hostel, Library fee and Refundable Mess Caution Deposit should not be collected from the students by the Education Institutions.
- (cc) Redressal Cell should be created in all Agricultural Institutions to redress the grievances of the students admitted under 7.5% seats on preferential basis.

- (vii) The Registrar, Tamil Nadu Agricultural University should ensure that benefits are taken only from one of the schemes viz. post-metric / first graduate / 7.5% seats on preferential basis and there should not be any duplication.
- (viii) The Tamil Nadu Agricultural University / Tamil Nadu Medical Services Corporation Limited should create a database of the beneficiary students with Aadhar seeding.
- (ix) The Academic fee includes Admission fee, Education fee, Library fee, Internet fee and Society charges, Development fund, Special fee, Computer fund, Education Media Service Charges, University Cultural and Professional Society Fee, Students Accident and Medical Service fee, Registration and Admission fee, Certificate Verification fee, Red Cross Society Member fee and Flag Day fee.
- (x) The Hostel fee includes Entry fee, Administration fee, Hostel Amenities fee, Development fee, Room rent, Electricity charges, Security charges and Monthly Mess fee.

4..The Managing Director, Tamil Nadu Medical Services Corporation is permitted to incur the above expenditure from the P.D. Account in the first instance and the Registrar, Tamil Nadu Agricultural University is directed to reimburse the above amount to the Tamil Nadu Medical Services Corporation after the release of grant to Tamil Nadu Agricultural University by the Government.
