Agriculture and Farmers' Welfare – Sugarcane – Fixation of mill-wise Fair and Remunerative Price (FRP) for 2019-2020 and 2020-2021 sugar seasons in respect of sugar mills in Tamil Nadu – Approved–Notification – Issued.

ORDER:

The Government of India announces Fair and Remunerative Price for sugarcane, every year on all India basis under the provisions of Clause 3 of Sugarcane (Control) Order 1966, which the sugar mills are bound to pay within 14 days of purchase of cane. The Government of India fixed the Fair and Remunerative Price for each sugar mill separately through a Gazette Notification up to 2018-19 sugar season based on previous crushing season average sugar recovery obtained by the sugar mills.

2. The Government of India vide its letter 1st read above has determined the Fair and Remunerative Price of sugarcane payable by Sugar Mills for 2019-2020 sugar season as detailed below:-

- (i) Fair and Remunerative Price of sugarcane for 2019-20 sugar season at Rs. 2750/- per Metric Tonne for a basic recovery rate of 10% ;

- (ii) A premium of Rs.27.50 per Metric Tonne for every 0.1% increase above 10% in the recovery ; and
- (iii) Reduction in Fair and Remunerative Price by Rs. 27.50 per Metric Tonne for every 0.1% decrease in recovery, in respect of those mills whose recovery is below 10% but above 9.5 percent. However, for mills having recovery 9.5% or below, the Fair and Remunerative Price is fixed at Rs. 2612.50 per Metric Tonne.

3. The Cabinet Committee on Economic Affairs vide reference 2nd read above has approved the Fair and Remunerative Price of Sugarcane payable by sugar mills for 2020-2021 sugar season (October 2020 to September 2021) on the recommendations of the Commission for Agricultural Costs and Prices (CACP) as under :-

- (i) Fair and Remunerative Price of sugarcane for 2020-21 sugar season at Rs.2850/- per Metric Tonne for a basic recovery rate of 10% ;
- (ii) A premium of Rs. 28.50 per Metric Tonne for every 0.1% increase above 10% in the recovery ; and
- (iii) Reduction in Fair and Remunerative Price by Rs 28.50 per Metric Tonne for every 0.1% decrease in recovery, in respect of those mills whose recovery is below 10% but above 9.5 percent. However, for mills having recovery 9.5% or below, the Fair and Remunerative Price is fixed at Rs. 2707.50 per Metric Tonne.

4. In continuation, the Government of India, Ministry of Consumer Affairs, Food & Public Distribution in its notification 3rd read above has delegated the powers conferred on it by clause 3(1) of Sugarcane (Control) Order, 1966 for fixing mill-wise Fair and Remunerative Price to be exercisable by the State Government / Union Territory from the sugar season 2019-20 onwards for the sugar mills wherein the concerned sugar mills is located.

5. Consequently, the Commissioner of Sugar in his letter 4th read above has stated that, as per the above norms, he has worked out the mill-wise Fair and Remunerative Price based on the average recovery of the sugar mills for both Public and Co-operative and also in respect of private sugar mills for 2019-20 and 2020-21 sugar seasons and requested to approve the same and to notify in Tamil Nadu Government Gazette as per the powers delegated in the Government of India, Ministry of Consumer Affairs, Food and Public Distribution Notification 3rd read above.

6. The Government, after careful examination, have decided to accept the proposal of the Commissioner of Sugar in para 5 above. Accordingly, the Government approve the mill-wise Fair and Remunerative Price (FRP) calculated by the Commissioner of Sugar based on the average recovery of the sugar mills for 2019-20 and 2020-21 sugar seasons and also decided to notify the same in the Tamil Nadu Government Gazette as per the powers delegated in the notification third read above.

7. The Notification appended to this Government Order shall be published in the Tamil Nadu Government Gazette.

8. The Works Manager, Government Central Press, Chennai-600 079 is requested to send 100 copies of the Notification as published in Tamil Nadu Government Gazette to the Government in Agriculture and Farmers' Welfare Department, Secretariat, Chennai-9 and to send the bill of cost towards publication of Notification to the Additional Chief Secretary / Commissioner of Sugar, Chennai-600 035 for settlement.

9. The Additional Chief Secretary / Commissioner of Sugar is directed to pursue further action accordingly.

In exercise of the powers conferred by Sub-clause (1) of Clause 3 of the Sugarcane (Control) Order, 1966, read with Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, Government of India, Extraordinary Notification No.G.S.R.663 (E)/ESS.Com/Sugarcane, published at pages 1-2 of Part – II Section 3 (i) of the Gazette of India, dated the 22nd October 2020, the Governor of Tamil Nadu hereby notify the Mill-wise Fair and Remunerative Price (FRP) for the sugar mills in Tamil Nadu for the sugar season 2019-2020 and 2020-2021 calculated based on the average recovery in previous sugar season, as follows :-
