### **ORDER:**

In the Government Order first read above, the Government issued orders for sanction of Rs.10.00 lakhs for the implementation of the scheme for composting of Farm Waste through Pleurotus during the year 2014-2015.

2. In the letter second read above, the Director of Agriculture has sent proposal to Government and requested that Rs.10.00 lakhs may be sanctioned for continuing the scheme for composting of Farm Waste through Pleurotus during the year 2015-2016. The Director of Agriculture has stated that under the scheme, 5000 kits, each kit cost Rs.200/- are proposed to be distributed at a free of cost to the farmers.

3. The Government examined the proposal of Director of Agriculture and accept the proposal, accordingly sanction a sum of Rs.7.00 lakhs (Rupees Seven Lakhs only) for implementing the scheme for composting of Farm Waste through Pleurotus during the year 2015-2016 for distributing 5000 kits each kit cost Rs.200/- at a free of cost to the farmers as detailed below:-

4. The sanctioned expenditure on para 3 above, shall be debited into the following Head of Account:-

"2401-00 Crop Husbandry – 105 Manures and fertilizers – I  
Non-Plan – AE Composting of Farm Waste through Pleurotus  
– 11 subsidies – 01 individual based subsidy."

5. The Government also directs the Director of Agriculture to send the progress report to the Government periodically.
