### ORDER:-

In the Government Order first read above, the Government have sanctioned the continuance of the scheme for the Bio – Fertilizer production Units for the period from 1.04.2014 to 31.03.2015 at a total cost of Rs.1271.72 lakhs.

2. The Director of Agriculture in his letter second read above, has sent proposal for sanction of the continuance of the scheme for Bio-fertilizer Production Units for the period from 01.04.2015 to 31.03.2016 as detailed below:-

3. The Government after careful examination has decided to accept the proposal of the Director of Agriculture. Accordingly, the Government permit to continue the scheme for production and distribution of Bio-fertilizer for the period from 01.04.2015 to 31.03.2016 and to accord sanction for Rs.1303.74 lakhs (Rupees Thirteen Crore three lakhs and seventy four thousand only) for the production of lignite based Bio – fertilizer at 3000 MT and liquid Bio – fertilizer at 2,50,000 Liters, subject to the recovery of expenditure in full, through sale amount and also permitted to incur expenditure of the sanctioned funds.

4. The above expenditure shall be debited to the following heads of accounts:-
