The Commissioner of Agriculture has stated that a sum of Rs.335.76 lakh was sanctioned as first instalment towards implementation of "Soil Health Management under National Mission for Sustainable Agriculture (NMSA)" during the year 2015-16, out of which a sum of Rs.25.964 lakh is available as unspent balance under the above project as on 1st April 2016. So, he has requested to incur the above said amount towards implementation of Soil Health Management under National Mission for Sustainable Agriculture during 2016-17.

2.
