



ABSTRACT

Agriculture – Cost of consultancy charges to NABCONS for conducting feasibility and fund requirement study for implementation of Integrated Farming System in Villupuram District as a District Saturation Model – Sanction of additional sum of Rs.2,75,010/- to NABCONS towards service tax – Accorded - Orders Issued.

ORDER:

In the Government Order first read above, an amount of Rs.22.25 lakhs was sanctioned towards the cost of consultancy charges to NABCONS for conducting feasibility and fund requirement study for implementation of Integrated Farming System (IFS) in Villupuram District as District Saturation Model.

2) In the letter second read above, the Director of Agriculture has informed that the Deputy General Manager, NABCONS has requested to pay Rs.22.25 lakhs towards the consultancy charges in two installments (i.e) Rs.11,12,500/- + service tax at 12.36% as advance and balance Rs.11,12,500/- + service tax at 12.36% before handing over the report. Accordingly, the first instalment of Rs.11,12,500/- and the service tax @ Rs.12.36% amounting to Rs.12,50,005/- was settled to NABCONS for undertaking the feasibility study. The NABCONS has also informed that the consultancy service fees were exclusive of the service tax and a service tax at 12.36% is applicable. The Director of Agriculture has also stated that the request for service tax as detailed below was

received from NABCONS only after the receipt of the G.O. Therefore, the proposed amount towards service tax was not included in the proposal for sanction of fund:-

Amount Sanctioned in Government Order	Rs.22,25,000/-
Amount required for making payment to NABCONS (inclusive of service tax@ 12.36%)	Rs.25,00,010/-
Balance amount required for making full payment to NABCONS	Rs.2,75,010/-

3) The Director of Agriculture has therefore requested the Government to sanction an additional amount of Rs.2,75,010/- towards full settlement of consultancy charges along with service tax to NABCONS.

4) The Government, after careful examination, accept the proposal of Director of Agriculture and they accord sanction for an additional sum of Rs.2,75,010/- (Rupees two lakhs seventy five thousand and ten only) towards service tax for full payment of consultancy charges to NABCONS for conducting feasibility and fund requirement study for implementation of Integrated Farming system in Villupuram District as a District Saturation Model.

5) The additional amount sanctioned in para 4 above shall be debited to the following head of account:-

"2401-00-Crop Husbandry- 103 Seeds - Schemes in the XII Five Year Plan - II State Plan - KU Integrated Farming System 33 - Payments for Professional and Special Services 03 - Special Service"

6) Necessary additional fund will be provided in FMA 2014-15. Pending provision of such funds in FMA 2014-15, the Director of Agriculture, Chennai-5 is authorized to draw and disburse the amount sanctioned in para (4) above. The Director of Agriculture, Chennai-5 is also directed to include the above item of expenditure while sending the proposal for FMA 2014-15 to Government in Finance (Agriculture) Department without fail.
