ORDER:

In Government order first read above, Administrative sanction was given for a sum of Rs.1938.8714 lakh, (i.e.Rs.1512.3197 lakh for General Category, Rs.407.1630 for SCSP Category and Rs.19.3887 lakh for TSP Category) for smooth and successful implementation of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 in Tamil Nadu.

- 2. In Government letter second read above, the Government have sanctioned an amount of Rs.19,38,870/- under TSP Category towards the implementation of Micro Irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16.
- 3. In the letter third read above, the Director of Horticulture & Plantation Crops has requested the Government to authroise him, to draw the balance amount of Rs.1919.4827 lakh, (Rs.1512.3197 lakh under General category and Rs.407.1630 lakh under SCSP Category) towards the implementation of micro irrigation under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16.

The Government after careful examination, have decided to accept the proposal of the Director of Horticulture & Plantation Crops /Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release an amount of Rs.1919.4827 lakh (Rupees Nineteen crore Nineteen lakh Forty Eight Thousand Two Hundred and Seventy only) (ie. Rs.1512.3197 lakh for General Category and Rs.407.1630 lakh for SCSP Category) towards the implementation of Micro Irrigation Scheme under PMKSY for which administrative sanction was already issued vide G.O.first read above during 2015-16 under the following head of account:-

scheme to Government, Utilization Certificates along with details of State share released under the said scheme shall also be sent to Government of Ind ia.
