### **ORDER:-**

In the Government order first read above, orders were issued sanctioning a sum of Rs.33,33,33,400/- as first installment which includes Government of India share Rs.20,00,00,000/- and State matching share of Rs.13,33,33,400/- towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2017-2018 in Tamil Nadu.

2) In the G.O. second read above, orders were issued sanctioning 2<sup>nd</sup> Installment for a sum of Rs.3545.6667 lakh, which includes Government of India share - Rs.2127.400 lakh and State share-Rs.1418.2667 lakh towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2017-2018 in Tamil Nadu.

3) In the letter 3<sup>rd</sup> read above, the Government of India has released 3<sup>rd</sup> installment as Central Share Rs.2000.00 lakh (General Rs.1600.00 lakh, SCSP Rs.380.00 lakh and TSP Rs.20.00 lakh) for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture (MIDH) during 2017-2018 in Tamil Nadu.

4) In the G.O fourth read above, orders were issued sanctioning a sum of Rs.2254.13 lakh as 3<sup>rd</sup> installment which includes Government of India share of Rs.2000.00 lakh and State Share of Rs.254.13 lakh towards the implementation of the National Horticulture Mission as per the approved Annual Action Plan 2017-2018 under Mission for Integrated Development of Horticulture and also ordered that the balance State Share will be provided in the financial year 2018-2019.

5) In the letter fifth read above, the Managing Director, Tamil Nadu Horticulture Development Agency has requested to sanction and release the balance 3<sup>rd</sup> installment amount of Rs.1079.21 lakh of State Share which has to be released under the General and SCSP Category as follows:-
