### ORDER:

In the G.O. 2<sup>nd</sup> read above, orders has been issued for the implementation of Sub Mission on Agricultural Mechanization for the year 2019-20 for the unspent

P.T.O

amount of Rs.13278.91 Lakhs (Rs.7967.346 Lakhs as GOI share and Rs.5311.564 Lakhs as State share) of the year 2018-19 for the components 1) Financial assistance for procurement of agricultural machinery and equipment, 2) Establishment of Farm Machinery Banks for Custom Hiring, 3) Promotion of Farm machinery banks at village level and 4) Administrative expenses.

2. In the G.O. 4<sup>th</sup> read above, Orders has been issued for the implementation of Sub Mission on Agricultural Mechanization for the year 2019-20 for the total outlay of Rs.11667.00 Lakhs which includes the Govt. of India share amount of Rs.7000.00 Lakhs and state share amount of Rs.4667.00 Lakhs for the components 1) Financial assistance for procurement of agricultural machinery and equipment, 2) Establishment of Farm Machinery Banks for Custom Hiring, 3) Hi-Tech, High Productive Equipment Hub for Custom Hiring 4) Promotion of Farm machinery banks at village level and 5) Administrative expenses.

3. The CE(AE) has stated that Since the component No 3. Financial Assistance for procurement of Agricultural Machinery and Equipment under Sub Mission on Agricultural Mechanization is implemented through Govt of India Direct Benefit transfer (DBT) portal [www.agrimachinery.nic.in](http://www.agrimachinery.nic.in) the machinery proposed under both the Govt Orders are consolidated and uploaded in the Annual Action Plan Module of DBT portal as detailed below;

The CE(AE) has stated that the proposal was sent to Government of India for approval of the revised target for utilizing the savings amount of Rs.1883.50 Lakh and upload the 514 Nos of additional machinery in the DBT portal. Further he has sent proposal to Government of India for approval of revised target proposed as per the requirements of Agricultural Machinery and Implements in the districts and by taking into consideration of waiting list applications in the DBT portal and to upload the revised target. Later he has sent proposal to Government for utilizing the savings amount of Rs.497.60 Lakh by uploading the additional machinery in the DBT portal. bsequently he has sent proposal to Government of India to approve the additional machinery proposed by surrendering the lesser demand machinery and to upload the same in DBT portal. Now based on the approval given by Government of India in its DBT Portal the CE (AE) has sent the machinery wise, Category wise machinery list to Government for providing necessary amendment in this regard.

5. Hence the CE(AE) has requested to provide necessary Amendment for the component of Financial assistance for procurement of agricultural machinery and equipment sanctioned vide G.Os 2<sup>nd</sup> and 4<sup>th</sup> read above, as detailed below, based on the approval given by Government of India in DBT-Portal, since the amount proposed for the components do not vary by altering the physical target of the machinery:-


