ORDER:

In the Government order second read above, orders were issued to accord Administrative approval for the implementation of Coconut Development Board assisted schemes 2022-2023 for Rs.1315.63 lakh which also includes the scheme "Laying of Demonstration Plots (First year – New)" at a project cost of Rs.7.00 lakh to be implemented in 40 Ha and "Laying of Demonstration Plots" (Second year – Maintenance)" at a project cost of Rs.8.75 lakh to be implemented in 50 Ha.

2. In the Government order third read above, orders were issued to accord financial sanction for a sum of Rs.15,22,500/- (Rupees Fifteen lakh twenty two

thousand and five hundred only) for the implementation of the scheme of "Integrated farming in Coconut holding for productivity improvement (Laying of Demonstration Plots (First Year-New) at a cost of Rs.7,00,000/- and Layout of Demonstration plot for (Second year-Maintenance) at a cost of Rs.8,22,500/- during the year 2022-2023.

3. In the letter fourth read above, the Coconut Development Board, Kochi has conveyed Administrative Approval for an amount of Rs.212.50 lakh in addition to the Budget sanction conveyed under the scheme Integrated farming for productivity improvement – Laying out of Demonstration Plot & Organic Manure Unit in farmers field in Tamil Nadu State during the year 2022-23 details are furnished below:-

The Government after careful examination of the proposal of Director of Agriculture hereby accord administrative sanction for a sum of Rs.212.50 lakh for the implementation of Integrated Farming for productivity improvement – Laying of Demonstration Plots covering an area of 700 Ha and Organic Manure Units 225 Nos during 2022-2023.

7. The amount received from the Coconut Development Board and the receipts by sale of seedlings under the scheme shall be credited under the head of account mentioned below:-

8. The Director of Agriculture is directed to take all necessary steps to follow up and get the entire amount from the Coconut Development Board for the implementation of the scheme, during 2022-2023.
